What data do we collect?

Frying Tuck Mobile Catering collects the following data:

- Personal identification information (Name, email address, phone number, etc.)

How do we collect your data?

You directly provide Frying Tuck Mobile Catering with most of the data we collect. We collect data and process data when you:

- Register online or place an order for any of our products or services.
- Voluntarily complete a customer survey or provide feedback on any of our message boards or via email.
- Use or view our website via your browser's cookies.

How will we use your data?

Frying Tuck Mobile Catering collects your data so that we can:

- Process your order, manage your account.
- Email you with special offers on other products and services we think you might like.

When Frying Tuck Mobile Catering processes your order, it may send your data to, and also use the resulting information from, credit reference agencies to prevent fraudulent purchases.

How do we store your data?

Frying Tuck Mobile Catering will securely store your data for the statutory 6 years from date of purchase. Once this time period has expired, we will delete your data.

Marketing

Frying Tuck Mobile Catering would like to send you information about products and services of ours that we think you might like.

If you have agreed to receive marketing, you may always opt out at a later date.

You have the right at any time to stop Frying Tuck Mobile Catering contacting you for marketing purposes or giving your data to other members of the Frying Tuck Mobile Catering.

What are your data protection rights?

Frying Tuck Mobile Catering would like to make sure you are fully aware of all of your data protection rights. Every user is entitled to the following:

The right to access - You have the right to request Frying Tuck Mobile Catering for copies of your personal data. We may charge you a small fee for this service.

The right to rectification - You have the right to request that Frying Tuck Mobile Catering correct any information you believe is inaccurate. You also have the right to request Frying Tuck Mobile Catering to complete information you believe is incomplete.

The right to erasure - You have the right to request that Frying Tuck Mobile Catering erase your personal data, under certain conditions.

The right to restrict processing - You have the right to request that Frying Tuck Mobile Catering restrict the processing of your personal data, under certain conditions.

The right to object to processing - You have the right to object to Frying Tuck Mobile Catering processing of your personal data, under certain conditions.

The right to data portability - You have the right to request that Frying Tuck Mobile Catering transfer the data that we have collected to another organization, or directly to you, under certain conditions.

Cookies are text files placed on your computer to collect standard Internet log information and visitor behavior information. When you visit our websites, we may collect information from you automatically through cookies or similar technology.

How do we use cookies?

Frying Tuck Mobile Catering uses cookies in a range of ways to improve your experience on our website, including:

What types of cookies do we use?

There are a number of different types of cookies, however, our website uses:

- **Functionality** - Frying Tuck Mobile Catering uses these cookies so that we recognize you on our website and remember your previously selected preferences. These could include what language you prefer and location you are in. A mix of first-party and third-party cookies are used.
- **Advertising** - Frying Tuck Mobile Catering uses these cookies to collect information about your visit to our website, the content you viewed, and the links you followed. Our Company sometimes shares some limited aspects of this data with third parties for advertising purposes. We may also share online data collected through cookies with our

advertising partners. This means that when you visit another website, you may be shown advertising based on your browsing patterns on our website.

How to manage cookies

You can set your browser not to accept cookies, and the above website tells you how to remove cookies from your browser. However, in a few cases, some of our website features may not function as a result.
